CR04 /2022 Vandal proof Benches Oakford Lawn

- Could you please let me know the cost of the Vandal Proof bench if purchased in Green and also if you are able to produce this in our colours – Burgundy RGB Colour R = 165 G = 0 = 33 and what the cost would be for this colour? – **Yes, cost to follow shortly, RAL 3005. We can do a red RAL 3020 as standard if that is suitable?**
- What material gauge is used for these Picnic Benches? **2 mm galvanized steel**
- Can plates be added to the legs of the benches so that they can be screwed down onto the concrete and covered with slabs? **We can supply extended legs at £ 75.00 + VAT, this is to be used to sunk the bench into wet concrete. Would this be suitable?**
- What would the lead time be if we were to order two benches? **Current lead-time is 20 weeks - estimated despatch date 22/4/2022**

Just waiting for an answer on the cost for burgundy but I will forward as soon as I have it.
