**96/19 Possible closure of Ashburton Fire Station -** Email below from the Town Clerk at Ashburton Town Council:

"I have been asked to contact you all regarding the news of the possible closure of Ashburton Fire Station. The town will fight the closure of this station and I have been asked if you will support Ashburton. If your council would like a presentation by Ashburton Fire Station please can you contact me to arrange this?"

- Ashburton Fire station is earmarked for closure under all 6 proposals that go forward to the Fire Authority on Friday. (FA made up of elected officials, not fire personnel).
- The stats being used by the Fire Service to justify the proposals only include statutory calls for fire and RTCs (Road Traffic Collisions).
- Ashburton station has skilled crew and specialised cutting equipment and appropriately sized vehicle for responding to serious/fatal RTCs. The proximity to the A38 classifies the station as strategic and they are often held back on multi pump responses to 'cover' the A38 which is high risk.
- Ashburton patch covers 85.75 km squared, one of the largest and extremely rural where local knowledge is vital in reducing response times.
- The Fire Authority's Safer System of Work requires a minimum of 9 firefighters to respond
  to any house fire, this means a minimum of 2 pumps as most vehicles can only crew 5, or 6
  maximum with some larger vehicles.
- The Roving Vehicle can only be crewed by 2 people, the impact on ability to respond within a Safer System of Work would be minimal especially as there are 5 rovers covering the whole of Devon & Somerset.

- The response requirement time is 10 mins for the 1st pump and 13 mins for the 2nd. Proposed closure leaves response times extremely vulnerable and therefore puts public at increased risk of harm.
- Ashburton has a 94% operational rate (hours that the pump is manned and 'on the run'.
  This is one of the highest in the region due to large local employer (Glendinnings) releasing
  employees to be available as necessary. Bovey Tracey is on the run for 82% as a
  benchmark.
- Four retained firefighters at Ashburton have provided an additional 8509 hours at no extra cost to the Fire Service over the last 12 months. This unpaid commitment has not been factored in to the proposed model.

# **97/19 Public Meeting July, 2018 -** Email received from Mrs Taylor:

"It has now been approximately 12 months since the public meeting. I would like to know what progress if any has been made on the comments made at this meeting.

There was a token 'speed watch' one Sunday morning shortly after the meeting which really didn't address the 'rat run' problem but guessed it was done to appease the public it would be interesting to know the results.

I look forward hopefully to a positive action plan."

Following on-going concerns from local residents about vehicle speed, on Friday 21<sup>st</sup> June 2019 our Special Constables supported by two of the Neighbourhood team conducted a speed enforcement operation

# 94/19 Planning Application for retention of Portacabin and Storage Container – update

The Planning permission that was granted for the Portacabin and Storage Container at the rear of the Community Hall was for three years and has now expired.

A new application was submitted on 1 April, 2019 with a decision date of on or before 27 May, 2019. I have been chasing Teignbridge District Council for a decision on this and have spoken to Planning today and been told that they have a lot of work on their desks and that they should be in a position to deal with our application within two weeks. I have diarised this and will chase again at that time.

# 95/19 Devon Air Ambulance – Update

The two gates have now been installed at Five Lanes playing field and coded padlocks installed. All details have been passed to Devon Air Ambulance and the site is due to go live any day now. Once the site is up and running Toby Russell will contact us and we can then proceed to arrange for an official opening of the site.

# 98/19 Kingsteignton Youth Centre – Appointment of one Charity Trustee

This is an extract from the section in the KYC constitution governing appointment of trustees:

- a) Kingsteignton Town Council ("the Nominating Body") may appoint one charity trustee
- b) Any appointment must be made at a meeting held according to the ordinary practice of the Nominating Body
- c) Each appointment must be for a term of 1 year.
- d) The appointment will be effective from the later of:
  - the date of the vacancy; or
  - the date on which the charity trustees or their secretary or clerk are informed of the appointment
- e) The person appointed need not be a member of the appointing body.
- f) A trustee appointed by the Nominating Body has the same duty under Clause 9(1) as the other charity trustees to act in the way he or she decides in good faith would be most likely to further the purposes of the CIO.
