39/18 DCC - Traffic Sensitive Street Review - Consultation period of one month w.e.f. 1 M\arch, 2018

As you may be aware, Devon are undertaking a full review of the traffic sensitive street network. Full details can be found on our webpages;

A statutory consultation period will be published for a 1 month period from the 1 March 2018. We are providing you with this information in advance of the consultation to enable you to feedback any thoughts you may have at an early stage. Feedback should be sent to the following email address:

Please be aware, Devon are governed by what can be designated traffic sensitive through regulations and statute – so we cannot designate routes outside of specific legal criteria.

Local Consideration Network

For those areas where legal designations as traffic sensitive cannot be made we are aware, as the highway authority, that early conversations and consultation on works would help reduce network disruption. We are therefore developing a secondary network of routes entitled 'local consideration'.

This is a network that will trigger a need for anyone planning works to discuss with local stakeholders at an early stage (i.e. at the point of noticing). The development of this network is ongoing, however, this network can be considered for areas where traffic sensitive designations do not apply.

40/18 Receipt of Crime Law and Order Petition from Mr Dave Grylls for discussion

A petition has been received in the Office from Mr Grylls which has been signed by residents wishing to call for an open meeting of the Council and for it to take place during the day on perhaps a Saturday. Concerns raised are:

- Complete disregard of the Highway Code in the town with repeated obstruction of zig zag marking at pedestrian crossings, vehicles parking on the approach and on roundabouts. Delivery trucks do this and for long periods
- Young people on bicycles repeatedly ride at speed on pavements and often weave in and out of normal traffic. Very few cyclists have lights during the hours of darkness, endangering themselves and officer.
- Parking on pavements outside shops, which restricts "wheel chair users and the partially sighted, apart from the public in general
- Young people congregate in large groups especially at the "Fountain" and areas around the town. These groups are very intimidating in their mannerisms and foul language and behave as though they are above the law. These groups are very intimidating in their mannerisms and foul language and behave as though they are above the law.
- Food Cartons and drink cans are simply discarded at will and in plain sight of an adequate bin
- Various drug paraphernalia have been found in parks and play areas.

- Many dog walkers still do not pick up after their dogs in many areas
- There are a few motorists who speed through the town at alarming speeds. Young and learner motor cyclist travel far too fast through heavily populated areas bearing in mind their speed and inexperience, this could prove fatal
- As New replaces Old watch out and report "Fly Tipping"
- Many vehicles throughout the town are badly parked and restrict the passage of Emergency vehicles.
