Teignbridge Local Plan Review

We are reviewing Teignbridge's Local Plan and we'd like you to have your say on the things you think the plan should cover.

What is the Local Plan?

The Local Plan is an important planning document which sets out the planning vision for the district and covers a range of topics including jobs, homes, facilities and environmental protection. It guides where development will and won't go up to 2033 and is our first consideration when planning decisions are made. The other parts of the 'development plan' are the Minerals Local Plan and the Waste Local Plan produced by Devon County Council and Neighbourhood Plans prepared by local communities.

This is the first review of the plan since it was adopted in 2014. We're consulting with statutory partners and anyone who is interested through a public consultation from 21 May - 16 July

2018.

At this stage, known as the 'Issues' stage, the review will address overall direction of the plan including possible places where development could take place. There is now an opportunity to:

- Extend the plan period to 2040.
- Respond to community ambitions for their area.
- Identify what has worked and what requires improvement.
- Align policies and proposals with the [Greater Exeter Strategic Plan](#).
- Update and reflect evidence.
- Reflect changes to legislation, national policy, guidance and adopted Neighbourhood Plans.

As part of the consultation you will be able to comment on supporting documents which directly impact on plan-making such as environmental assessments, settlement boundaries, settlement hierarchy and Statement of Community Involvement. In future stages, there will be opportunities to comment on draft policies and potential development sites.

I do understand and share some of your frustrations, and can confirm that since the new year we have increased the number of gangs tackling potholes on the highway network.

The two snow events in March has exacerbated the situation but we are working hard to manage the work alongside our contractors.

I have asked for the outstanding potholes along Longford Lane and Greenhill Way roundabout at Next, to be prioritised as a matter of urgency and repaired.

In terms of our longer term plan for the roads you mention there is positive information that I can inform you of;

- Longford Lane forms part of this year's resurfacing programme and is currently being designed.
- Exeter Road, Ley Lane junction running north to extend past Chockland Rd junction, is proposed to be fully resurfaced for delivery in next year's programme.
- Exeter Road, Ley Lane junction running south towards Fountain Rnbt, is proposed to be surfaced with a micro asphalt treatment, for delivery in next year's programme.
- Tesco Rnbt towards Jewson's along Newton Rd, is proposed to be fully resurfaced, for delivery in next year's programme.

I trust you find the above information helpful in understanding that we are aware of the current issues, and have a strategy in place to deal with them longer term.

As always feel free to get in touch should you require further information or want to discuss any issues which are causing you concern.

Good morning,

Could you kindly forward my email to the relevant contact?

Whilst receiving chemo earlier this year I'm afraid I was unable to attend the last town meeting where I believe the proposed roadworks at the end of Broadway road joining Exeter road were discussed?

I moved into my Redrow home two years ago now with my baby and partner. I must say I do feel rather blessed to have such a wonderful view of Ducks, Geese and the occasional Swan on the pond when I open my curtains.

The reason for my email is to inquire as to why this patch of nature is going to be disturbed to make a slight amendment to the end of a road? We currently have a natural sound barrier from the passing traffic on Broadway road as there is a beautiful row of large trees there.

I am really concerned that the costly work of adjusting this road to go between two ponds could become quite a dangerous section for our developments children to walk along to St Michaels School whilst vehicles pass them if the road isn't of a significant width. Will there be the inclusion of a safe raised path for pedestrians? With two way traffic I'd hate to find myself having nowhere to safely walk along without the risk of being knocked into the water! I'm puzzled as to why the current end of road can't be slightly adjusted to the edge of the smaller pond instead of carrying out such a major job between the two ponds?

If somebody could please my mind at rest and explain exactly why this proposed work is happening I would be most grateful.
