**F63/18** Communities Together Fund – previously known as the Elector Fund – Details for information

Devon County Council has approved a budget of approximately £660,000 for 2018/19 for the new Communities Together Fund (CTF) which will replace the Town and Parish (TAP) Fund (Elector Fund). The City, Borough and District Councils also contribute to the fund.

The CTF is to encourage two or more communities to work together to identify new ideas for their mutual benefit. It is money to help 'kick-start' local projects, encourage local action, and help get good ideas off the ground; enhancing and making a real difference to local communities.

The Communities Together Fund (CTF) was previously known as the Elector Fund. The CTF can be used by towns, parishes and community groups working together to respond to community issues of shared interest and/or concern.

The CTF is a useful way of supporting a wide range of local projects across the district such as:

- Local economy, employment and welfare (for example community shops, food banks, homelessness)
- Community events and celebrations (for example community shops, food banks, homelessness)
- Community facilities (for example community facility improvements, community safety improvements)
- Sport, leisure, arts, heritage, culture (for example Youth Clubs, Libraries, Allotments, Theatres, Plays, Music) and
- Highway improvements (for example grit bins, signs, safety improvements, bridges traffic regulation orders, rights of way, weeds). Town and parish councils, constituted community and voluntary groups (including "Friends of" groups), registered charities, faith groups and social enterprises may apply for funding.

Projects/activities can be as big or small as the issue you wish to solve.

Town and parish councils, constituted community and voluntary groups (including "Friends of" groups), registered charities, faith groups and social enterprises may apply for funding.

The CTF will open for applications from 1 November, 2018.

In readiness for when the applications open, councillors are asked to consider how they would like to use this fund and what other community/ies they could work with.

"We've had some more Section 106 money in from Linden Homes for Penns Mount 12/01737.

The final 25% of the Public Open Space contribution, which is £37,852.50

£605.64 per dwelling towards the cost of providing and/or enhancing playing field provision within a 3 mile radius of the land.

The code is XW7 999 0075 and the spend by date is 27 November 2021

The second 50% of the £500,000 towards the cost to DCC of constructing the South Devon Link Road.

This money is being sent to Devon County Council."
