CR38/2020 Apologies

Resolved: Apologies received and accepted from Cllr B Austen who had a family commitment.

CR39/2020 Declarations of Interest

CR40/2020 Minutes of the Community Hall and Recreation/Footpaths and Fountain held on September 2020.

Resolved: That the chairman sign the minutes.

CR41/2020 Clifford Park Update.

Cllr R Peart addressed the meeting with the following update:

- Stage 1: It is possible that an application to Viridor could be made for the maximum grant of £100,000. To do this a copy of the constitution, Postcode, and the land registry documentation in relation to the ownership of Clifford Park is required
- Stage 2: An outline plan of work to be done is required. This grant then needs to be applied for by 31st January 2021 for completion by 31st March 2021.
- Lorraine Montgomery to look at costings and take to TDC board.

Resolved: That:

- Cllrs Scagell and Peart to continue with the Viridor funding application.
- As previously agreed, the project will be Council led. The sub-committee managing the project comprising of Cllrs Scagell, Rollason, Peart and Ripping to meet along with a representative from Proludic.



- Mrs Lewis-Clarke to contact to FOCP and advise them of the progress and that the Council will now lead the project.
- Mrs Lakin to provide copy of constitution and Land Registry document.

CR42/2020 To discuss proposal by Cllr Scagell to remove benches from Oakford Lawn and storage during winter months.

Resolved: That:

Cllr Jones take the following proposals to Oakford Lawn Trustees committee for consideration:

- Re-seed grass areas where benches are currently located.
- Install slabs
- Install pavers to match the new pathway.
- Move the benches to a position nearer to the CCTV

CR43/2020 To discuss and agree budget for Christmas lights.

Resolved: That a budget of £3,000 be agreed.
