# 137/2021 To discuss increased community cohesion through considerations of existing community produced plans and any suitable review process which might include a Neighbourhood Plan

To discuss 'the need, wish or requirement for increased community cohesion and/ or resilience through considerations of existing community produced plans and any suitable review process which might include a Neighbourhood Plan. Also looking during any community contact consultation towards anything that could build our community as a whole through creativity, communication, explanation, marketing and supporting of various community functions suggested examples might be:

security( through Community Watch),

**Social activity groups** to support them with small grants (not having to wait until March to May) and to help them to attract membership through advertising them and keeping our listings up to date maintaining GDPR authorities etc.

Adult education including IT skill delivery and other basics

**volunteering groups** (suggest using the environment wardens and our support and maybe using volunteers to help out the vulnerable etc),

**Procurement** (domestic and council use, getting a decent list of local tradespeople and give some effort to managing the list to assist us in collecting local quotes)

Support networks and digital channels we might support FB, NextDoor,

I have prepared a summary and attached the relevant reference files to get to grips with what we have produced in the past to give some direction and focus to where the Council was going to be headed over the last 9 years. To my surprise we haven't done too bad at all and as you will see we stack up quite well against the delivery of the Community Plan of 2012. Of course you may think differently and I would hope you would comment to us all as to what you think.

Kingsteignton Community Plan and Kingsteignton Town Centre as part of the TDC Towns and Villages Project both of 2012 - the files are attached - please take a look as both were ground breaking at the time and possibly the place to start now - the Community Plan covered the whole Town and the Town Centre plan just the area around the old Town - but both have uncompleted ideas and could include a good foundation to start this consultation?

This was effectively the last time the Town was consulted as we decided never in the last 9 years to attempt a Neighbourhood Plan and spend £25000, sponsored by others, to investigate the needs of our Town!

Indeed some (well one person) might think why did we not do a Neighbourhood Plan instead of a Community Plan - simple - people could never get sufficiently involved and trained to actually be first on projects to push our point of view successfully. Also it was based on never politically accepting the housing required and so, throughout everything, all that could be produced was 'damage limitation' from the housing and offering infrastructure physically and socially to possibly 'soften the blow'.

However, as was suggested many years ago, if we had been the first (rather than now, the last) with sponsorship and ultimate help to make it work as a Neighbourhood Plan we might have enjoyed a happier community, more aware , more involved and more able to accept their responsibilities for the future when perhaps councils will be removed from the planning



procedure and the current, seemingly 'unresponsive' residents, carrying the only 'voice' in the development process.

#### Moving on to what were we looking at in the Community Plan 2012:

#### Three main themes

1. Develop a town "focus" – a physical place to meet, to socialise and for the generations to mix and enjoy

2. Encourage people to meet with one another, get to know each other and understand each other

3. Create a place where people want to live, work, learn, play and visit

#### 16 projects were assembled to deliver improvements to each of these themes.

#### Theme 1 - Develop a Town 'Focus'

#### PROJECTS

- 1. Physical centre produce a Town Centre Plan see the Kingsteignton Teignbridge Towns and Villages Project. File attached. COMPLETED (but not adopted)
- 2. Vision and physical plan for whole Town see TDC Local Plan 2014 COMPLETED (- largely done 'to us' rather than 'by us' as we did not produce a Neighbourhood Plan)
- 3. Ensure sufficient infrastructure provided see New School Kingsteignton School imperative in 2012 - COMPLETED.

#### Theme 2 - Encourage residents to meet, know and understand each other.

#### PROJECTS

- 4. Develop initiatives for resident interaction on issues using the Transition Town network and concept *tried but no community traction. NOT COMPLETED*
- 5. Protect residents from ASB/ community safety closer liaison with Police see Cllr Advocate scheme 2019 - PARTIAL COMPLETION (WIP)
- 6. Promote use of existing Community Groups- see use of existing community groups to publicise issues and collate feedback NOT ADOPTED BY SUCCESSIVE MAYORS NOT COMPLETED
- 7. Enable greater use and promote survival of Kingsteignton Swimming pool see KTC involvement annual funding and successful interest by KTC COMPLETED.
- 8. Develop youth facilities (KYC and Skate board half pipe) See brilliant work by many to deliver excellent facilities 2021 COMPLETED
- 9. Promote and develop cycle routes see signage, routes adopted and many peripheral success stories work on new Teignbridge project commenced! ONGOING COMPLETION

10. Provide community sports facilities - see support to Football Clubs, boxing and other small clubs - PARTIAL COMPLETION

#### Theme 3 - Create a place where people want to live, work, learn, play and visit

#### PROJECTS

- 11. Improve : pedestrian safety, parking, reduce speeding and reduce congestion see ongoing HATOC representation for yellow lines, pedestrian crossings, some reduction in speed limits, speed monitoring by Police and Speedwatch (about to resume), input towards Bus service review by DCC. ONGOING COMPLETION
- 12. GREEN SPACES. Protect, maximise use of existing, create new green spaces by publicising and negotiation see allotment success vs wider community involvement, footpaths support, wasted resources (Rydon Road Football pitch), upgrading local parks and ineffective new green space procurement strategies. ONGOING COMPLETION
- 13. Make a cleaner unpolluted Town see Air quality work, support for litter picking, cleaning of the Fountain and excellent general maintenance/upgrades. Discussions on rewilding vs tidiness. Effective monitoring of Sibelco and Viridor - and new industrial units. ONGOING COMPLETION
- 14. Improve access to and use of health services see managing improvements ( not at any cost) poor current relationship after COVID no overall plan NOT COMPLETE
- 15. Develop adult education communication plan see KTC web site NOT COMPLETE
- 16. Improve visitors access to information see KTC web site (?) signage, liaison with other tourist offices, connection with heritage sites, overall plan required and funding allocated to redevelop after pandemic? NOT COMPLETE

#### CONCLUSION on the Community Plan from 2012 in 2021

Much work over the years has been towards delivering the Community Plan or so it seems in retrospect. Of course this could be by chance or perhaps the plan was close to the reality of things as they were/are required along the way. This I believe is further support that we seem to have been delivering the wishes of the residents and this would be the way to go forward again by some sort of consultation although with the time allowed it might be collaboration/ consultation using some of the unfulfilled ideas and adding some new and bigger picture type thoughts and then consult with the residents afterwards. This would allow us to get some thoughts and suggestions in the pot for future times and the thought processes we go through may bring up some interesting new concepts especially around air quality, infrastructure and most importantly the climate change and ecological emergency making it a truly relevant review for today.

#### CONCLUSION on the Town Centre Plan 2012 and relevance to 2021

I ask you to take a look at the findings and residents responses but consider whether any of the recommendations could stack up as possible items on the 'Wish List' for Kingsteignton in 2021.

The project was a very involved affair and did stimulate some thoughts of redevelopment but various groups always felt they had to lead from the front and failed to gain the trust of the Council to follow behind them and take a risk with the 2014 version of the suggested Fountain redevelopment. Personally I feel there are many parts of the proposed recommendations that could still be tested for relevance today and maybe could form part of the "Building back better" recovery plans. What do you think - were you aware of this project?
