#### WSP29/2022 Kingsteignton Wild

#### **Budget**

A budget of £2000 was agreed for this project at the WSP meeting on 19 January 2022.

I am a little confused from the minutes at this meeting, as unless the Town Council are going to transfer the funds to Kingsteignton Wild, then the trail will have to use our account. This needs to be discussed and made clear what councillors wish to do.

If the budget is to be managed by the Town Council, then all purchases and payments would need to be made by the Town Council so that VAT could be claimed back by us. If purchases are made by Kingsteignton Wild and the invoices passed to the council to pay, then the VAT is not reclaimable, but the minutes say that they are not to use our financial accounts, which means that they would have to have their own account and the council would need to clarify that the £2000 was to be transferred to them. This would then be credited to an account in their name and monitored by them.
