WSP40/2022 Kingsteignton Senior Citizens Club (WSP 72/2021)

A response has been received from Oakford Stationers advising that they would be happy to see a sign for a maximum speed of 5pm to be placed on their left hand column for traffic accessing the Lawn but not sure where a sign could be placed exiting the Lawn.

Resolved:

- That the Clerk liaises with Oakford Stationers as the wording requested by the Senior Citizens Club was "Slow Down Pedestrians" and not 5 mph to see if they would be happy for a sign with this wording.
- That the Club be advised of the outcome of the wording for the sign and that a
 budget of £50 be agreed to supply the sign. The Senior Citizens Club to be advised
 that this is being paid for by the Town Council as a one off as we do not own the lane

WSP41/2022 Kingsteignton Bowling Club

A request has been received from The Secretary, Kingsteignton Bowling Club for assistance in arranging a contractor or financial assistance for the tarmac to the front and sides of the clubhouse to be repaired. The tarmac has started to break up due to age and small sharp particles are ending up on their new carpet, which could cause damage to the fibres.

Resolved: that a letter be sent to the Bowling Club asking them to provide three quotes and submit these to the Council, together with photos of the tarmac surface needing attention. This request for funding will then be considered by the Town Council.
