Representatives from Kingscare gave a presentation of the work they wanted to do with a Dementia Café in Kingsteignton and for which grant funding of £1,407.60 was sought. After Kingscare left, Councillors discussed the application.

In particular he drew attention to the fact that, although the deficit was much larger for the year to date than forecast, this was entirely due to the fact that a large amount of expenditure was incurred in the first quarter only, whereas expenditure per the budget assumes an even spread of expenditure. Allowing for these items he reported that the Council is "on budget".
